The Correspondent, “**Sir C Ramalingareddy College, (Sir CRR Educational Institutions) Eluru**” has applied for opening **Sir CR Reddy High School, Opp. Police Petrol Bunk, 21 division, Santhinagar, Eluru Mandal, Eluru District** with classes **I to X EM** during the academic years from **2025-26**. In the reference 4th cited the Government of Andhra Pradesh has accorded opening permission for the classes **I to X (EM)** at Strerch for the academic year 2025-26 and directed the Commissioner of School Education AP Amaravathi & Regional Joint Director of School Education Kakinada is requested to take necessary action.

Basing on the above instructions the Regional Joint Director of School Education, Kakinada has accorded opening permission for the classes **VI to X EM**, for the year 2025-26 and requested to take necessary similar action for opening of classes **I to V (EM)** to the above said school as per Rules 3(1) of GO MS.No.1 Education Dept, Dated.01-01-1994.

Basing on the above instructions and orders of the proposals from the society and also the inspection report of the Inspection officer in the references cited, permission is hereby accorded for opening of new school in the name **Sir CR Reddy Primary School, Opp. Police Petrol Bunk, 21 division, Santhinagar, Eluru Mandal, Eluru District** with classes **1st to 5th** (English Medium only) during the year 2024-25 in subject to the following conditions:

1. That the permission/Recognition accorded is valid for mentioned school building address classes, medium and the period only, if the school building and or address changed and / or other classes and / or medium opened without proper permission from the competent authority, he permission /recognition will be cancelled without prior notice.
2. That the society shall abide to the instructions, rules and regulations made in the Government order cited above.
3. That the society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, library, laboratory equipment play field required staff as per the staff pattern and other facilities which are necessary, before approaching the competent authority before applying for recognition.
4. That the society shall apply for recognition 31st August duly fulfilling the conditions from time to time.
5. That the permission accorded is restricted to this year only and it is not valid for the subsequent academic year if the Management has not applied for according Temporary recognition as per rules in force.
6. That this permission does not confer any right on the society for claiming recognition.

7. That the permission is accorded **Sir CR Reddy Primary School, Opp. Police Petrol Bunk, 21 division, Santhinagar, Eluru Mandal, Eluru District** and no other society or body can open a school on their behalf.
8. That this permission is accorded to open the school in the premises in which the management has submitted documentary evidence only, and there shall not be any change in the premises or locality.
9. The society shall provided necessary teaching learning material even if it costs more than the deposit amount.
10. Proper and adequate sanitation facility shall be provided for students especially for Girls students.
11. That the institute shall adopt the curriculum and syllabus prescribe by the Government from time to time.
12. That the school timings, vacations and mid term holidays shall be maintained as prescribed by the Government and or District authority from time to time.
13. That the qualified staff, within the age limits and qualifications prescribed by the Government for Government employees shall be followed and shall be appointed as per the staff pattern.
14. The results of the institutions shall be satisfactorily every year.
15. That the records, Audit reports, Administrative report and list of Government body of the Educational society shall be furnished to the District Educational Officer, Eluru District every year by 30th September at the latest.
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
18. The parent teacher associations meeting shall be conducted to sensitize he parent on the safety of the children.
19. The school shall have first aid kit and teachers shall be trained in first aid.
20. The correspondent of the concerned school is hereby informed to file an affidavit before 30th April every year to the effect that there is no deviation or violation of norms prescribed by the Govt from time to time and submit the same to this office without fail.
21. That the management shall ensure the accounts of this school audited by an authorized chartered accountant every year by 30th April without fail and submit promptly.
22. The management has to maintain trained teachers at all time.
23. The management schools fulfill all the conditions as per GO.Ms.No.41 Education dated.11-05-2006 a the time of applying of provisional recognition.
24. The management is hereby informed that, the permission is being given purely on temporary basis and is subject to the report of the state level inspection and vigilance committee fulfilling of all the prerequisite conditions under AP Education Act, 1982 and it later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.
25. The management is here by informed to follow the guidelines issued in GO MS No 91 Education Dated.06-08-2009 regarding fee structure in private schools. Fee structure fixed by the Governing body shall be got approved by the authorities for every year.
26. The Management is informed to obtain the occupancy clearance from the fire services department authorities concerned for the entire period of recognition without fail.
27. Opening permission orders now accorded is subject to genuineness of the Fire NOC form the fire authorities.
28. That the school timings, vacations and mid-term holidays shall be maintained as prescribed by the Government and / District authority instructions from time to time.
29. The management is informed to submit Audit reports at the time of Recognition and to improve the library books.
30. The management is informed to obtain vehicles fitness certificates from the concerned RTO's.
31. That all the conditions prescribed in the RTE Act 2009 and Government orders from time to time which are not specified in these orders shall also be complied with.

32. That the school shall not be closed without giving notice both to the parents and District be given to close the school only from the date on which summer vacation is declared.
33. If any deviation on the specified conditions herein and also the Government orders from time to time, action will be taken to cancel the school Recognition.
